## Online Registration (OLR) Version 6.5.14 (4/9/2026)

**This version of Online Registration is compatible with Campus 2615.0 and later.**

### Fixes

- An issue existed that allowed deletion within an application with read-only rights. This has been corrected. (CDP-4914)

## Online Registration (OLR) Version 6.5.13 (3/6/2026)

**This version of Online Registration is compatible with Campus.2551 and later.**

### Enhancements

- A previous issue caused data changes with Configuration copy. This package includes an insert script that moves the original default values into the new table for any notifications that are missing table data. (CDP-4904)

## Enhancements

- The Notifications editor was updated to expand user functionality for fields "Status, Only Send for School, Only Send for Grade, and User Group to Receive Notifications" to allow multiple selections at once instead of a single selection. (CDP-2074)
- A settings page has been added for Open Enrollment.
  - An Add rights restriction was also added to the Create button on the Application Search screen to align with the result screen logic.
  - A filter has also been added to the Open Enrollment Application tool that prevents a user from selecting the same Preference multiple times for a student when adding a new application. (CDP-4324)
- Several updates have been made to the Open Enrollment > Lottery tool.
  - Added an approved column to the grid and updated Status column to show all statuses for user clarity
  - Update process to reset unlocked approvals prior to processing to avoid seat count irregularities
  - Added an option to lock applications from processing immediately upon Lottery execution (CDP-4560)

## Fixes

- An issue existed that did not allow a user to review open enrollment application results or

accept/deny an open enrollment application in the portal after the application was posted. This has been fixed. (CDP-4792)

## Online Registration (OLR) Version 6.5.9 (12/10/2025)

### Enhancements

- As announced earlier this year, the New Application Processing functionality has replaced the Classic Application Processing functionality (formerly known as Staff Processing) to coincide with the core Infinite Campus release 2551. (CDP-4532)

### Enhancements

- Several updates were made to Open Enrollment including adding an audit table to track Batch Updates, Lottery Run and Enrollment Posts along with a Process History tool to view the results. Accessibility updates were also implemented. (CDP-4325)

## 6.5.7 (11/21/2025)

This version of Online Registration is compatible with Campus.2535 and later.

### Enhancements

- When working in Student Processing, the "Cancel" button has been renamed "Go Back". This returns the user to the Search Results screen and clarifies the action being taken. (CDP-4020)
- Census > Open Enrollment > Application search tool Response field has had the following options added: Awaiting Response - Filters for all responses that are empty, Awaiting Response/Allow Accept - Filters responses that are empty and also have Allow Accept checked. (CDP-4421)
- Several fields within Student Processing search have been updated to allow the selection of multiple values when searching: Student Grade School Application Status. (CDP-4428)
- Several buttons have had their verbiage updated to better reflect the action being taken: After an application has been processed/approved, the status pill has been updated to reflect "Submitted" instead of Approved Update from "Process Application" button to "Submit to Open Enrollment" button. - Program and Category flags have been added as search options. (CDP-4515)

### Fixes

- Custom OLR builder has been updated to return only one name per Preference code. (CDP-4503)
- The new Application Processing tool Potential Matches was not working as Classic did; this has been fixed. (CDP-4516)
- A tool rights error was preventing Student Grade Level search from correctly working; this has been fixed. (CDP-4564)
- A Mailer send issue existed when descriptions exceeded a character count. The Mailer name has been updated to Type to ensure this issue will no longer occur. (CDP-4569)
- A person linking error existed within the Search People by Criteria option; this has been fixed. (CDP-4573)
- A tool rights issue existed when utilizing the Check Batch Qualifications for Application button; this has been fixed. (CDP-4586)

## Online Registration (OLR) Version 6.5.5 (11/6/2025)

### Enhancements

- The Application Processing search screen has expanded to allow users to search by Application Grade. (CDP-2811)
- A warning message has been added to the Student Review screen within Application Processing to alert users when the student is listed as a member of a Secondary Household. (CDP-3828)
- Confirmation screens were added to several Application Processing functions to allow users to confirm their chosen actions. (CDP-4052)
- Several fields on the Application Processing search screen were updated to multi-select fields to expand functionality for users. (CDP-482)

### Enhancements

- Fields within the OLR Builder have been renamed to better align with their purpose to assist users. Post object has been renamed to Post to Campus Tab and Post element has been renamed to Post to Campus Field (CDP-1930)
- Name fields within the application have been updated to not allow the characters ", (, or ) to ensure consistency with the Core Campus product. (CDP-2747)
- An update has been made to ensure that if a district requires at least one Emergency Contact the validation occurs within an application if emergency contacts are removed. (CDP-3010)
- Prevent Posting of Application if Any Address in Application is not Linked setting has been set to unlocked for all users in DE. (CDP-4344)

- An issue existed with Portal Messages not showing correctly - this has been fixed. (CDP-2940)
- An issue existed where users were unable to delete the Signature field in the OLR Builder - this has been fixed. (CDP-4230)

- Fixed an issue where secondary household guardians were showing up in applications, all with the same name. (CDP-4267)
- Fixed an issue where Application Processing would freeze upon clicking "Next" if there was an existing primary home address that had not changed, and there was a new mailing address that was not linked and had not changed in the application. (CDP-4263)
- Removed case sensitivity with email matching in Application Processing. (CDP-4247)
- Fix an issue where the Application Queue option in Application Processing was not appearing. (CDP-4246)
- Fixed an issue where the Literals Column in the OLR Literals Bank was not able to be seen/edited under certain circumstances. Now users can adjust the size of each column using the line between each column header at the top of the page. They can also scroll to the bottom to use a scroll bar to move across the page. - Fixed an issue where having required fields in the Relationship - Other Household section were causing the student record to not validate. (CDP-4236)
- Fixed an issue where the "Disable Posting for" button was appearing for existing people. (CDP-4190)

## OLR 6.5.0 (7/10/25)

This version of OLR is compatible with Campus.2523 and later.

### Enhancements

- With OLR 6.5.0, we are releasing the new Open Enrollment functionality! (CDP-4216)
  - Open Enrollment allows districts to create Open Enrollment applications and run lotteries for their available seats. It is integrated with OLR Prime to make a seamless workflow for both parents and staff.
  - This will eventually replace the School Choice functionality, but both will co-exist for a period of time.
  - **Please note:** The old School Choice and new Open Enrollment features cannot be used together. Only one of these can be active at a time.

- The OLR Literals Bank will now use the WYSIWYG Editor for the majority of its literals. Any existing HTML will still function, but any newly entered HTML moving forward will not work. Some literals will not use the WYSIWYG Editor to preserve functionality/overall formatting of the OLR Application. (CDP-4033)
