Campus.2547 (November 17, 2025

New! Groups - A Staff, Parent, and Student Communication Tool

A new Groups tool has been added to Campus Learning. This tool allows users to create groups that include students, parents, and staff members and communicate with them via Campus. These groups can be created around events, topics, organizations, and interests. Depending on group settings, members can create posts and reply to others in the group.

Group Owners can

- Create groups and determine the posting permissions for that group.
- Make the group public, so that any users in the district can request to join the group, or set the group to private so that only users who are invited can join.
- Participate in the group, including creating posts and replies and flagging inappropriate content.
- Moderate groups and resolve flagged posts.
- Manage group membership.
- View communication history for the group, which maintains original content if editing content is enabled.
- Archive groups that are no longer needed.

Only staff members can be given the role of Group Owners.

Group Members can

- Post and reply in the group, depending on group settings.
- Flag inappropriate content.
- Search for groups to join.

Staff, parents, and students can be members of groups.

Note: when a student wants to join a group, their guardians must first provide approval.

The Groups Administration tool allows administrators to oversee the use of groups, including resolving flags and other Group Owner tasks. Access to this tool is governed by the Groups Administrator tool right. Group Administrators can see any Groups tied to "All Schools" and to any Schools to which that user has calendar rights. This level of access should be given sparingly. At



this time, groups should not be created that need to be private at the district level. For example, Campus would not recommend creating a private group of all principals at the district. That group would be visible to any users at the district with the Group Administration tool right.

Access to the Groups tool is granted to staff members via tool rights. Additionally, a System Preference must be enabled to turn on Groups for a district. An additional setting is available to automatically add a student's guardians to any groups the student is a member of. The Campus Digital Repository must also be enabled for groups to share images and attachments.

Math Equations in Rich Text Fields

This enhancement allows users to insert mathematical equations into rich text fields in curriculum. Click the equation button to build a math equation using common mathematical operators, characters, and formulas. The feature makes it easier for teachers in math and science courses to include complex equations in quizzes and other assignments, beyond what can be typed using a standard keyboard.

Smaller Changes

The following smaller changes have been made to Instruction tools:

- Previously, the "Go To Student Information" link in Campus Instruction > Students >
 <u>Attendance</u> released in Campus.2543 didn't work in staging and sandbox sites and other test
 environments. This issue didn't occur in production sites and has been corrected.
- The attendance <u>seating chart</u> now displays correctly in full screen when taking attendance. This resolves an issue where the seating chart did not fill the entire screen after recent updates to the Attendance list released in Campus.2543.

The following changes have been made to tools that require a Campus Learning license:

- Viewing assignments in the <u>Standards Portfolio</u> has been updated to make the screen readonly. Previously, options to reassign, edit, and save assignments displayed in error in this view.
- Previously, when creating a Matching, Ordering, or Number Line <u>question</u>, the placeholder text didn't clear when the user clicked a response cell to add text. This has been corrected.
- Teachers can now use the <u>Curriculum Copier</u> without requiring calendar rights to previous school years.
- Previously, an error occurred when a user clicked Add to Section in the <u>Other Planners</u> view of the Planner, and the section selector didn't load in the copier tool. This has been corrected.
- Previously, when viewing an assignment in the <u>Curriculum Copier</u> or Library, the Reassign to All Students button displayed in Preview view when it shouldn't. This has been corrected.

Campus.2543 (October 20, 2025)

Attendance Tool Upgrade

The <u>Attendance</u> tool in Instruction has been updated to improve the visual design and accessibility of the tool. Tabs at the top of the tool allow you to switch between the Attendance List and the



Seating Chart. In the Attendance List, a Summary section displays at the top if Virtual Attendance is set up.

With this change, an option has been added to easily switch between Periods using the buttons on the right when Classroom is enabled. Previously, this option was not available if a teacher had the Classroom view enabled.

Additionally, taking attendance via the Teaching Center has been updated to make the experiences more consistent. When taking attendance in the Teaching Center, you now have the option of sticking with the narrower, mobile-friendly view, or toggling on the Extended View, which matches the design of the Attendance tool.

New - Quiz Timers

An option has been added to <u>Quiz Settings</u> to set a Time Limit for a quiz. Teachers can also set a Warning Time to let students know when their time limit is approaching. Once a timer is enabled in the Quiz Settings, a teacher can individualize the timer and warning via the Section Settings of the assignment.

When a timer is set, it displays for students when they're working on a quiz. When the timer expires, the quiz is automatically submitted with whatever work the student has completed at that point.

Smaller Changes

The following smaller changes have been made to Instruction tools:

- <u>Assignment Marks</u> have been updated so that if a set of marks is aligned to an assignment, it cannot be deleted.
- A link to "Go to Student Information" has been added to the student details side panel in various tools in Instruction that did not previously have this link. The link displays if the teacher has tool rights to any tools in Student Information > General. Clicking the link opens the Student Information menu in a new browser tab, where the teacher can select which tool they want to view based on their tool rights.
- The Other Sections/Schedules area of the assignment editor has been updated so that sections of courses marked as Course-Only Curriculum do not display in the list. Course-Only Curriculum is a Course Master-level setting that prevents teachers from aligning assignments from Course-Only sections to any other sections.

The following changes have been made to tools that require a Campus Learning license:

 Logic has been updated to consistently apply the default setting to hide student names and comments from parents in a Section Feed, even if section-level settings haven't been saved.

Campus.2539 (September 22, 2025)

My Curriculum



A new tool called <u>My Curriculum</u> has been added to Instruction. This tool allows teachers to create folders, assignments, and resources outside of the context of a section. Teachers can build out curriculum, with content, quizzes, etc, and then add it to their sections later. From My Curriculum, teachers can add curriculum to individual or multiple sections at a time.

Benefits of My Curriculum:

- Teachers don't have to worry about dates when creating curriculum. They can create the curriculum and then schedule it into sections later.
- My Curriculum provides a workshop area where teachers don't have to switch between section contexts or worry about draft curriculum being visible to students.

The Enhanced Curriculum tool right grants access to My Curriculum. This tool does not currently allow teachers to add curriculum from their sections into My Curriculum, or from My Curriculum directly into the Curriculum Library, but these features will be available in the coming months.

The <u>Curriculum Import</u>, which is currently in a limited beta release, has been moved to the My Curriculum tool. Teachers with access to the Curriculum Import can import curriculum into My Curriculum and edit it prior to adding it to their sections and making it visible. To accommodate this new tool, the My Curriculum and Other Curriculum views in the Planner have been renamed to <u>My Planner</u> and <u>Other Planners</u>.

Categories Redesign

The <u>Categories</u> tool has been updated to improve the visual design and accessibility of the tool. Functionality of this tool has not changed.

Smaller Changes

The following smaller changes have been made to Instruction tools:

- Previously, an error occurred when viewing Instruction tools with <u>Classroom</u> turned on when the context was set to All Years and All Schools. This has been corrected.
- When an assignment is assigned to multiple sections, those sections are listed in the Other Sections area of the <u>assignment</u>. Logic has been updated so that when a teacher clicks a section in that area, the section context at the top of the screen is updated to that section.
- The <u>Curriculum Copier</u> has been updated to restore previous logic when copying curriculum to a destination section that has no tasks/standards aligned, or no tasks/standards in common with the source section. In either of these scenarios, the assignments are now copied as Resources, with Grading toggled off.
- The Term filters in the <u>Curriculum tool</u> have been updated so that any curriculum that is in progress during the selected term is included in the list. For example, if an assignment has a Start Date in Term 1 and an End Date in Term 3, if the Curriculum List is filtered to Term 2, that assignment is included in the list.

The following changes have been made to tools that require a Campus Learning license:

• Previously, an error occurred when attempting to <u>reassign</u> a submission assignment to more than one student. This has been corrected.



- Matching and ordering quiz <u>question types</u> have been updated to include rich text editors for answer options, allowing teachers to enter images and formatted text.
- If a teacher clicks <u>View Submissions</u> in the submission scoring screen, a new Submitted By column in the table of submissions displays the name of the submitter if it was someone other than the student.
- As a result of a recent update, teachers, students, and parents were unable to open Google Drive files. This has been corrected.

Campus.2535 (August 25, 2025)

Submit as a Student - Quizzes

The option to submit work on behalf of a student has been extended to include quizzes. For example, a teacher could print out a quiz for a student who needs a paper copy and then enter the student's answers on their behalf.

To submit a quiz for a student, use the **View as student** dropdown list at the top right of the screen to select a student. Then click **Start Quiz** and enter the student's answers. The teacher's name is associated with the work they submit for a student. Note: teachers cannot submit a quiz for a student if the student has started the quiz online already.

Curriculum Library - Single Items

The Curriculum Library has been updated to allow users to add single items, such as an assignment or resource, to the Library. Previously, only entire folders of curriculum could be added. If viewing the library with Resources rather than Folders selected in the Content section, new Included Tasks filters allow users filter by items with quizzes, submissions, discussions, or LTI linked content. Assignments with Engagement Check-Ins and those received via a OneRoster integration cannot be shared to the library.

Smaller Changes

The following smaller changes have been made to Instruction tools:

The posting grades process in various Instruction tools has been updated to auto-post grades
for students whose Roster End Date is on or after the last day of the term. The workflow for
posting grades for students with End Dates has been improved by adding clarifying messages
to inform teachers which students will receive posted grades and why.

The following changes have been made to tools that require a Campus Learning license:

- A Feedback button has been added to various areas of quizzes. This button links to a forum post where users can provide feedback about quizzes, including recent improvements.
- As a result of a recent change, the Grade Book no longer updated when a score was entered on a Scoring Rubric or the submission scoring screen. This has been corrected.
- Previously, users encountered an error when attempting to access to the Standards Portfolio



from Progress Monitor and Student Information. This has been corrected.

Grading Scales Redesign

The <u>Grading Scales</u> tool in the Grade Book has been updated to improve the visual design and accessibility of the tool. Functionality of this tool has not changed.

Smaller Changes

The following smaller changes have been made to Instruction tools:

Previously, the Grade and Comments sort buttons in the <u>scoring screen</u> were not working.
 This has been corrected.

The following changes have been made to tools that require a Campus Learning license:

- Previously, changes to <u>assignments</u> were not saved if those changes were made in the code view. This has been corrected.
- The <u>Curriculum Import</u> has been updated to increase the maximum size for curriculum cartridges to 350 MB. This tool is in a beta testing period and only available in some districts.

Campus.2527 (June 30, 2025)

New! Section Feed - Generally Available

A new <u>Section Feed</u> tool has been released for Instruction users. This tool collects communications for a section, consisting of posts by teachers and students and their replies. Teachers can create posts and replies; students' communication options depend on the Section Feed Settings but may include posting, replying, and uploading attachments. To view a section's feed, click the speech bubbles icon in the Teaching Center or view the Classroom screen.

Section Feeds are <u>enabled</u> for students and parents via the Portal Display Options. A <u>Section Feed Administration</u> tool allows admins to view feeds for sections and resolve flagged replies.

Quiz Printing Feature

Teachers can now <u>print quizzes</u> for students unable to use computers. Printed quizzes closely resemble the digital versions taken by other students. Teachers also have the option of printing an answer key that includes the answers and settings selected.

Student Groups Redesign

The Student Groups tool has been updated to improve the visual design of the tool. The tool now



includes a Group View, which lists all of the groups for that section, the number of members, and available actions to take for that group. In the Student View, students are listed with their assigned groups.

The process for creating student groups from Score Analysis has also been updated to improve usability.

Period Schedule Display and Section List Order

Previously, if a section was included in multiple period schedules, the name of one of the period schedules was appended to the section name in some Section dropdown lists, including in the Grade Book and Post Grades. Logic has been updated to clarify when the Period Schedule(s) should be listed for a section. If a Calendar has multiple Period Schedules and a section is not in all of them, the Period Schedule(s) are listed after the Section name in parentheses. Period Schedules are not listed in the following instances: a section is in all Period Schedules, a section is in only one of multiple Period Schedules, or a section is in multiple Period Schedules but all additional Period Schedules are marked as an Exception/Special Day schedule in the Period Setup tool.

Logic for the order in which sections are listed in these dropdown lists has also been updated. Sections are listed based on the Sequence of the Term, then whether the Period Schedule is marked as an Exception/Special Day, then by the Sequence of the Period Schedule, then by the Sequence of the Period, then by Course Number and Section Number. Note: the order of the Section list is determined the first time the sections are scheduled and does not change. So, if a section meets during different periods on different days of a Period Schedule, the Section list will stay in the same order based on the first day and not reorder for that day's schedule.

Smaller Changes

The following smaller changes have been made to Instruction tools:

• Previously, the Flags dropdown list in the Scoring screen was truncated on smaller screens or when zoomed in. The dropdown list now displays correctly.

The following changes have been made to tools that require a Campus Learning license:

- The process for manually <u>scoring quizzes</u> has been updated. To change the auto-calculated score for a question, click Edit Score and enter the new score. This process prevents auto-calculation logic from overwriting the manually-entered score if it is triggered again.
- Previously, the Flags dropdown list displayed behind other parts of the Submission Scoring screen. This has been corrected.

Campus.2523 (June 2, 2025)

Curriculum List - Visual Improvements

Improvements have been made to the Curriculum List to make navigation options more clear, especially when accessing the List from the Teaching Center. The three numbers that display for



curriculum items have been redesigned to display as buttons. Teachers can easily score an assignment from the Teaching Center by clicking the assignment icon to open the List and then clicking the Scored button to open the scoring screen. From there, click Close to return to the Curriculum List.

Curriculum Import - LTI Links

An additional option has been added to the Curriculum Import to facilitate importing curriculum even if no LTI connections have been configured. If the curriculum cartridge being imported includes LTI links, users have two options:

- Set Up a Single Learning Partner for All Links
- Skip Setup and Remove Links

The first option requries that the relevant LTI program to have an existing connections in the Digital Learning Applications Configuration tool to be selected in the import.

If the user does not have the Enhanced Curriculum tool right, or rights to Digital Learning Applications Configuration or District Import, the import automatically applies the Skip Setup and Remove Links option.

The Curriculum Import is in a limited beta testing period and is only available in select districts.

Smaller Changes

The following changes have been made to tools that require a Campus Learning license:

- Logic has been updated so that when a user uploads an image in a WYSIWYG editor, the District Acceptable Use Policy displays alongside the Campus Terms of Service.
- Previously, if a teacher entered a score for a quiz that differed from the calculated score, the new score sometimes didn't save properly. This has been corrected.
- Previously, if a teacher reassigned a quiz that included a multiple choice question with multiple correct answers, correct answers were being marked as incorrect. This has been corrected.
- The Curriculum Import has been updated to handle content with large file attachments more efficiently.

Campus.2519 (May 5, 2025)

OneDrive - File Attachment

OneDrive has been added to the list of available LTI connections. This type of connection supports attaching files from OneDrive to assignments in Campus. Tech admins should see the <u>Configure OneDrive Connections</u> article for more information.

Smaller Changes



The following smaller changes have been made to Instruction tools:

• Updates have been made to improve the accessibility of scoring screens in Instruction, including keyboard navigation and screen reader behavior.

The following changes have been made to tools that require a Campus Learning license:

- Previously, student submissions didn't display in the scoring screen until the user clicked Save. This has been corrected.
- The Campus integration with Lockdown Browser has been updated to support Chromebooks.
- Previously, assignment flags prevented students from submitting their work for assignments
 with Submissions enabled. When any flag (Turned In, Missing, or Incomplete) was attached to
 a student's assignment, the submission option was unavailable regardless of the
 assignment's start and end dates. Logic has been updated so that students can submit
 assignments within the start and end dates, even if a Missing or Incomplete flag is present.
 Marking the Turned In flag still closes the assignment from having submissions submitted.
- The error message displayed when a file size limit is exceeded during curriculum import has been improved. If the file(s) attached to items in the imported curriculum exceed the file size limit of the Campus Digital Repository, the following message displays: "This resource could not be imported. The file exceeds the storage limits for the Campus Digital Repository." and files are listed.
- Previously, the Description field in the Details tab of Curriculum displayed HTML tags instead of images and formatting. This has been corrected.
