The following corrections are included in Rx Packs for December 2025. Rx Packs contain a small number of critical cases to fix urgent issues, with delivery in an immediate time frame (e.g., the fix cannot wait for the next four-week Release Pack).

It is recommended that customers apply all subsequent Release Packs immediately following Rx Packs. Doing so will benefit both customers and Infinite Campus when it comes to supporting the patch.

Rx Packs are cumulative; each Rx pack will automatically include all previous Rx packs within that release. These cases will also be included in the Campus.2603 pack unless otherwise noted. Rx Packs may occasionally skip a release number for Rx builds that were not made generally available.

An issue was fixed where the incorrect person was displaying as a student's service provider on the Special Ed Caseload. This occurred when a Service record did not have a Start and/or End Date. When the Service record does not have a Start and/or End Date, the Caseload looks to the Plan's Start and End Dates to determine the service provider display.

### Localization - Tennessee

#### Tennessee – Ed-Fi Resync Resource List Update (SIS-194823)

A Category Sort option and a Dependency Sort option have been added to the Ed-Fi Resync tool to allow users to sort the resource list by category or by dependency order. This update helps districts to resync data more accurately with fewer errors due to missing resource elements.

#### North Carolina - Summer Education Assessment Used Update (SIS-196236)

On the Summer Education Program, the RNS: Renaissance Star (Reading) Assessment was incorrectly named in the Assessment Used list of selections. This has been corrected.

### Student Locator Wizard Performance Improvement (SIS-195964)

Users encountered lengthy wait times for the Student Locator Wizard to load search results after updates were made to the tool in the Campus.2551 release. To improve performance and ensure consistency across various school districts and states, these changes have been reverted. The issue that was previously addressed in the Campus.2551 release will be resolved in a future update if necessary.

## Localization - North Carolina

### North Carolina - PMR FATAL, WARN Data Validations Update (SIS-195550)

The PMR Data Validation of FATAL-26 has been changed to WARN-06. Logic for this validation has also been updated to check the Day Event Types that have a Standard Code of AD: Abbreviated Day, instead of a DayEvent type of "AD."

### North Carolina - CTE Program Auto Assign Processing Issue (SIS-195761)

The CTE Program Auto Assign Task Scheduler was stuck in an indefinite "Processing" state. This caused the End Time to populate with the same value as the Start Time, so no actual updates to CTE Programs were made. This has been corrected.

#### Google Drive Integration - Support New Permission Enforcement (SIS-194713)

Google Drive is updating its permission enforcement - users will no longer be able to have less than full edit rights to a file that is in a folder that they own. This update ensures that file permissions are properly managed when transferring ownership between teachers and students, preventing potential access issues.

### Localization - Iowa

The logic for the 'STEMPar' extended element was updated on StudentSchoolEnrollment to consider the 'STEM Program' checkbox implemented in the Campus.2603 release. It now reports '1' when a student is rostered into a course section where the 'STEM Program' checkbox is selected. Otherwise, '0' is reported.

The SIF extended element 'STEMPar' was added to StudentSchoolEnrollment as part of the Campus.2551 release. In preparation for reporting this new element, a STEM Program checkbox has been added to the State Defined section of the Course Information and Course Master Information tools. This allows districts to mark courses associated with the STEM grant program. Students enrolled in these marked courses will be considered STEM participants.

A STEM Program checkbox has also been added under the State Defined section of the Section Information tool as an override option.

The User Account Type Wizard tool has been updated to include account type switching for accounts with null SAML configuration IDs. This change ensures that local authentication and LDAP accounts are now properly updated in the wizard's query results.

### Localization - Delaware

[Delaware-Driver's Education Custom Forms Updated \(SIS-195027\)](#)

New versions of the Driver's Education custom forms were added in the Campus.2547 release. The forms have been updated to prepopulate the certificate number field with the two-digit School Year and State Student ID (e.g., 26-123456). Users should verify that the School Year field in the State Defined Elements section of the student's Driver's License record is correct to ensure an accurate certificate number.

The FATAL-26 data validation rule has been updated to check for Calendar Day events labeled as AD: Abbreviated Day.

When a student is marked absent on an abbreviated day, those attendance minutes are not included in the FATAL-26 calculation. Rather, the first instructional day that is NOT abbreviated or is null is used for the remainder of the FATAL-26 checks.

Grade levels are now correctly displayed in the Progress and Course Plan areas of Academic Plans. This resolves an issue where grade level information was not appearing as expected.

## Localization - California

[California - Attendance Recovery Nightly Process for Hours Earned Issue \(SIS-193488\)](#)

A new System Preference has been added, Use Standard Recovery Calculation, for use with Attendance Recovery. This preference can be used by districts that rely on Section Attendance (students are marked as present, absent, or tardy) to track Attendance Recovery hours.

The default option is set to Yes, and only needs to be changed to No when directed by Infinite Campus.

A student was not included in the report when they turned 2 on or before August 1st and turned 3 on or before December 1st for the Fall Enrollment Count or March 1st for the Spring Enrollment Counts extracts.
