## Assessment

Assessment Import Updates (SIS-193958) **[Enhancement]**

The Assessment Center score importer has been enhanced to support [vertical file imports](https://kb.infinitecampus.com/help/vertical-file-score-import-assessment-center) (<https://kb.infinitecampus.com/help/vertical-file-score-import-assessment-center>), in addition to the existing horizontal file format. Vertical files allow for one score per row with multiple rows per student, while horizontal files have one row per student containing all scores. The 'Apply to All' feature is now only visible and functional for Horizontal orientation. Additionally, unique assessment names within an assessment "family" are now required to save new or modify existing assessments. These improvements facilitate the direct import of vertical score files from national assessment vendors, eliminating the need for manual conversion.

Once curriculum is copied to My Curriculum, teachers can work on it outside of the context of a section, using their existing curriculum as a starting point for building their own curriculum collection.

This copy process is done using the Curriculum Copier, selecting the Section as the Source and My Curriculum as the Destination.
